PharmacyChecker.com Verification Program

Online pharmacies must meet important safety criteria to qualify for approval in the PharmacyChecker Verification Program:

- Pharmacy license (with applicable pharmacy board or licensing authority)
- DEA-issued license for controlled substances (for U.S. pharmacies only: non U.S. pharmacies are not permitted to ship controlled substances into the U.S.)
- Prescription is required (based on an in-person examination, with exceptions where expressly permitted by law)
- Privacy policy (one that affirms a consumer's information will not be shared with third parties)
- Financial and personal information is secure (encryption required on web pages where financial and personal information is transmitted)
- Contact information (mailing address and phone number)

To ensure compliance with the Verification Program prescription requirements, PharmacyChecker.com conducts periodic "mystery shopping" by posing as a consumer attempting to purchase medication without a prescription.

PharmacyChecker.com works with experts to conduct inspections of licensed pharmacies in certain foreign countries to be sure that they adhere to high standards of pharmacy practice.

Look for the Seal!

If you see our seal on a pharmacy website that means it is in our Verification Program and meets our safety criteria. But be careful! Rogue online pharmacies publish fake seals. To make sure a seal is valid, check that it has today's date and links to a page hosted on www.pharmacychecker.com and provides a profile of the site.

High Drug Prices Are a Public Health Crisis in America¹ International Online Pharmacies Can Help²

- **Fifty million** Americans did not fill a prescription due to cost in 2012.³
- **Twenty-five million** Americans reported becoming sicker because they are not taking medication due to its cost.⁴
- Cost is the **number one** reason Americans don't fill prescriptions, according to a survey of CVS pharmacists.⁵

Protecting Americans from Rogue Online Pharmacies and Counterfeit Drugs

Today, millions of Americans buy medication from Canada and other countries online, despite federal prohibitions.⁷ In 2008, the Center for Studying Health System Change, a program of the Robert Wood Johnson Foundation, recommended creation of “A user’s guide and price comparison tool for Canada-based or other foreign-based online pharmacies.”⁸ This is precisely what PharmacyChecker.com provides.

Unfortunately, thousands of prescription drug selling websites do not follow safe online pharmacy practices. These sites usually don’t require prescriptions or they ask consumers to fill out an online questionnaire that is not appropriately reviewed by a licensed prescriber. These “rogue online pharmacies” are even known to intentionally sell counterfeit and adulterated drugs. Many of these sites pretend that they are safe Canadian pharmacies.⁹

There are no reports of serious adverse reactions or deaths resulting from medication ordered from an international online pharmacy that required a valid prescription. One comprehensive review of patient harm incidents resulting from online pharmacies between the years 2001-2012 found that all involved controlled drugs and/or websites that did not require a valid prescription.¹⁰ Several peer reviewed studies demonstrate the safety of international online pharmacies approved by PharmacyChecker.com.¹¹ By using PharmacyChecker.com-approved sites, consumers can avoid rogue pharmacy dangers while finding much more affordable medication.



All prescription orders received by PharmacyChecker.com approved international online pharmacies, which came from a variety of countries (not just Canada) were genuine medications (all but one marketed by Pfizer and AstraZeneca: 90.3% (177) were identical to drugs sold in the U.S. by the same manufacturer; 8.7% (17) were foreign versions made by Pfizer or AstraZeneca; less than 1% (1) was a generic substitution, which according to Mr. Bate contained the right active ingredient and dosage).
